We attach a petition objecting to the above planning application taken among the community of Bridgham, in which our poll indicates the following:

We attempted to poll every property in the village, however, a few were unoccupied when we called, but we consider overall that this is a true representation of the concerns of the community.

The main areas of objection were:

- The loss of productive farmland to an industrial development.
- The scale of the proposal in relation to the small village of Bridgham.
- The negative ecological impact of such a large development.
- The health risk from electromagnetic radiation from the cluster of inverters.
- The fact that there is no local benefit from the development and that the power generation from the site is not required locally.
- The negative visual impact, as this development will be clearly visible from the road and the Thetford end of the village. Most people do not believe that the hedging will screen the site, at present the hedging is in full leaf and the fields are clearly visible.

We believe that this petition gives a strong message to Breckland Council that the majority of the community of the village of Bridgham are opposed to this inappropriately located development.
